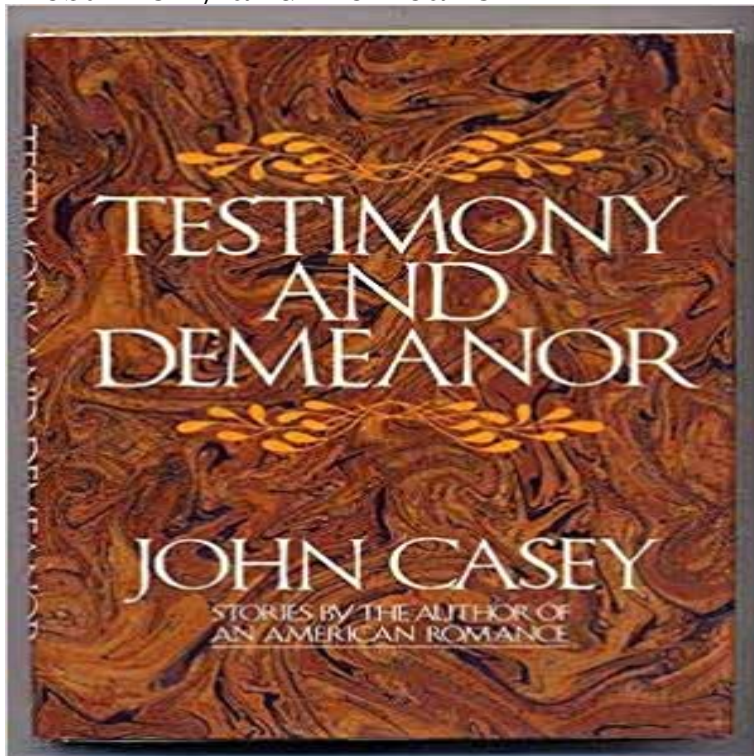


Testimony and Demeanor
