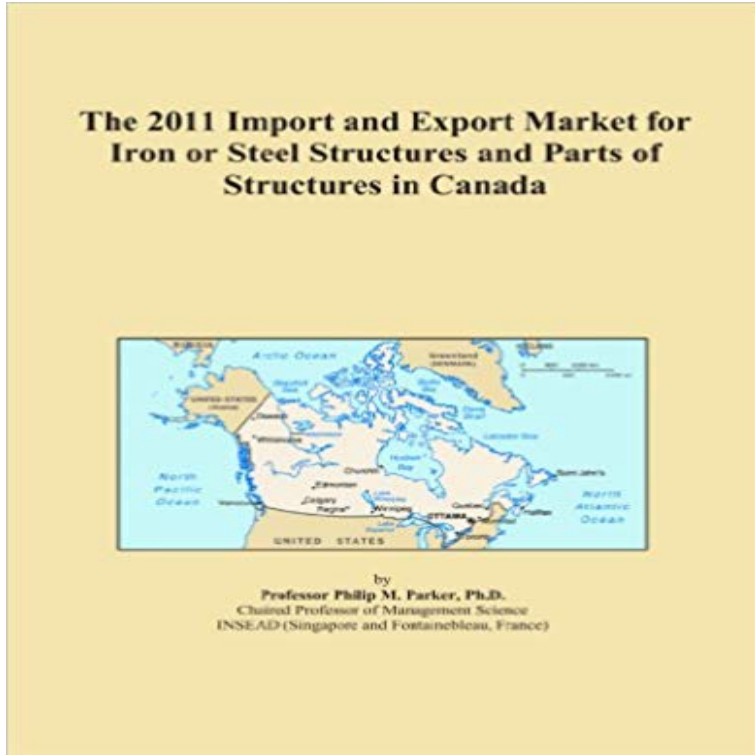


The 2011 Import and Export Market for Iron or Steel Structures and Parts of Structures in Canada



On the demand side, exporters and strategic planners focusing on iron or steel structures and parts of structures in Canada face a number of questions. Which countries are supplying iron or steel structures and parts of structures to Canada? How important is Canada compared to others in terms of the entire global and regional market? How much do the imports of iron or steel structures and parts of structures vary from one country of origin to another in Canada? On the supply side, Canada also exports iron or steel structures and parts of structures. Which countries receive the most exports from Canada? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for iron or steel structures and parts of structures in Canada. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for iron or steel structures and parts of structures for those countries serving Canada via exports, or supplying from Canada via imports. It does so for the current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2 begins by summarizing where Canada fits into the world market for imported and exported iron or steel structures and parts of structures. The total level of imports and exports on a worldwide basis, and those for Canada in particular, is estimated using a model which aggregates across over 150 key country markets and projects these to the current year. From there, each country

represents a percent of the world market.
