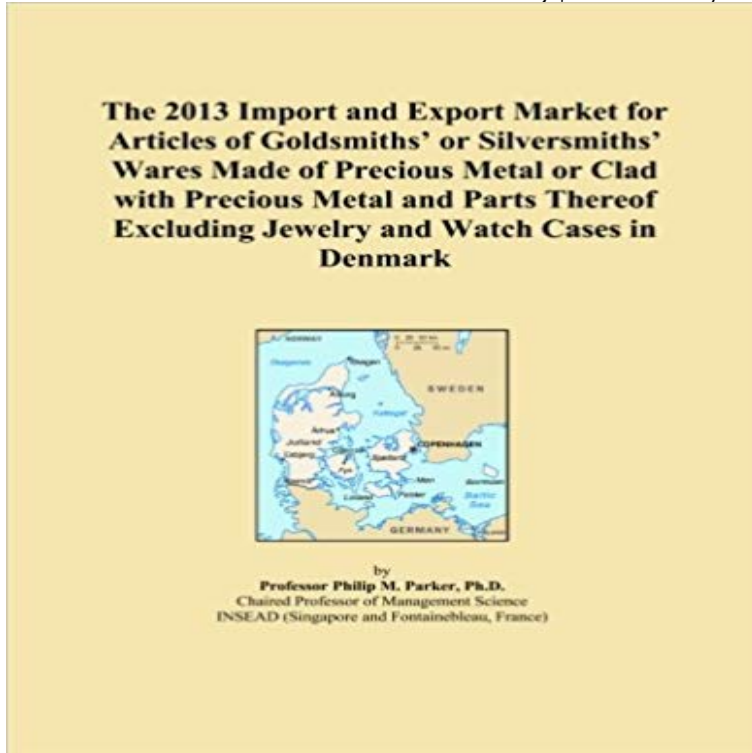


## The 2013 Import and Export Market for Articles of Goldsmiths or Silversmiths Wares Made of Precious Metal or Clad with Precious Metal and Parts Thereof Excluding Jewelry and Watch Cases in Denmark



On the demand side, exporters and strategic planners focusing on articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases in Denmark face a number of questions. Which countries are supplying articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases to Denmark? How important is Denmark compared to others in terms of the entire global and regional market? How much do the imports of articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases vary from one country of origin to another in Denmark? On the supply side, Denmark also exports articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases. Which countries receive the most exports from Denmark? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases in Denmark. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for articles of goldsmiths or silversmiths wares made of precious metal or clad with precious metal and parts thereof excluding jewelry and watch cases for those
