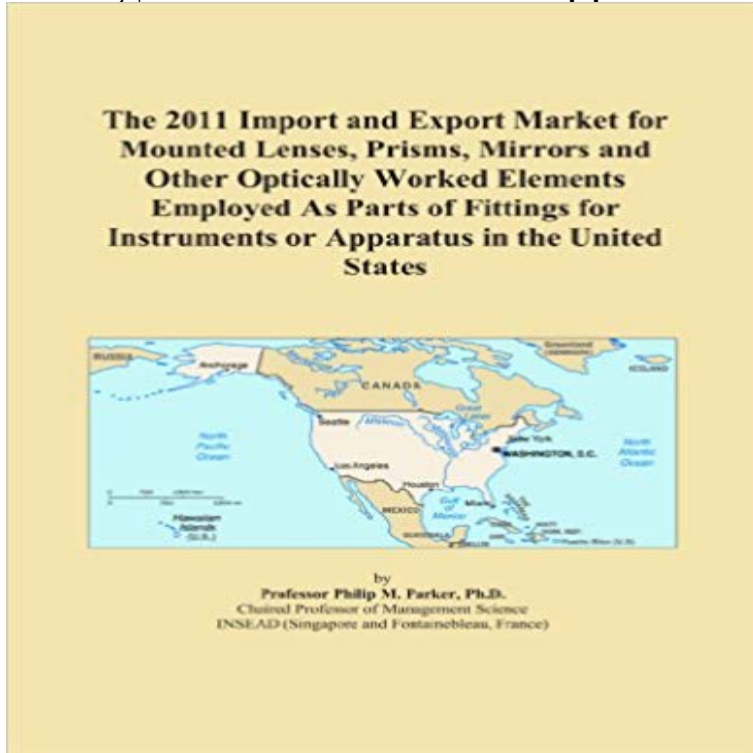


The 2011 Import and Export Market for Mounted Lenses, Prisms, Mirrors and Other Optically Worked Elements Employed As Parts of Fittings for Instruments or Apparatus in the United States



On the demand side, exporters and strategic planners focusing on mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus in the United States face a number of questions. Which countries are supplying mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus to the United States compared to others in terms of the entire global and regional market? How much do the imports of mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus vary from one country of origin to another in the United States? On the supply side, the United States also exports mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus. Which countries receive the most exports from the United States? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus in the United States. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for mounted lenses, prisms, mirrors and other optically worked elements employed as parts of fittings for instruments or apparatus for those countries serving the United States via exports, or supplying

from the United States via imports. It does so for the current year
