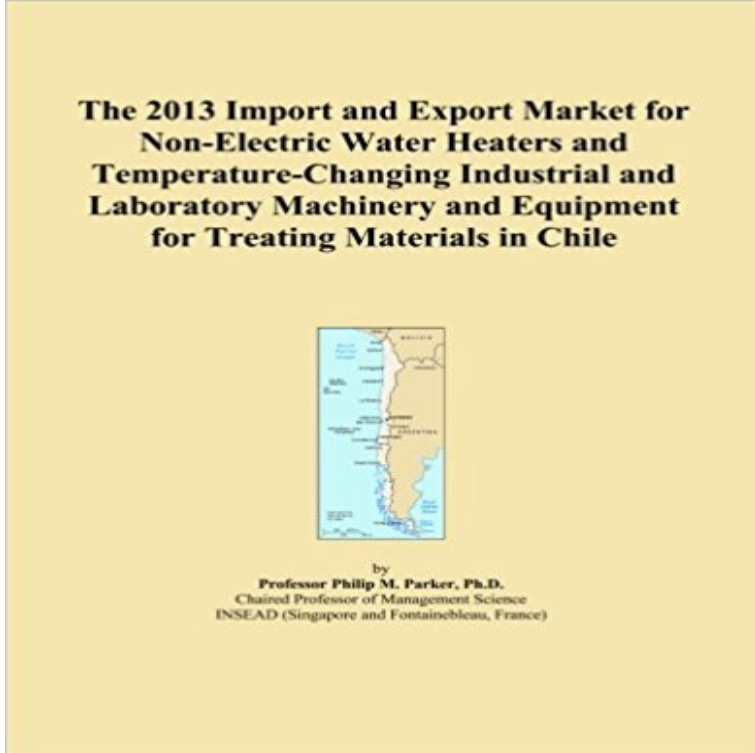


The 2013 Import and Export Market for Non-Electric Water Heaters and Temperature-Changing Industrial and Laboratory Machinery and Equipment for Treating Materials in Chile



On the demand side, exporters and strategic planners focusing on non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials in Chile face a number of questions. Which countries are supplying non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials to Chile? How important is Chile compared to others in terms of the entire global and regional market? How much do the imports of non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials vary from one country of origin to another in Chile? On the supply side, Chile also exports non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials. Which countries receive the most exports from Chile? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials in Chile. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for non-electric water heaters and temperature-changing industrial and laboratory machinery and equipment for treating materials for those countries serving Chile via exports, or supplying from Chile via imports. It does so for the

current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2
