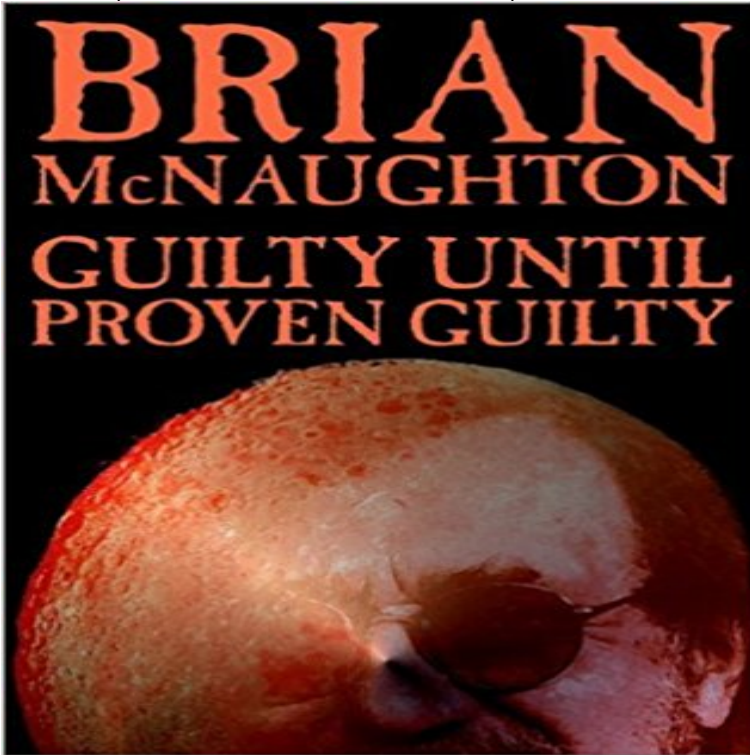


## Guilty Until Proven Guilty
