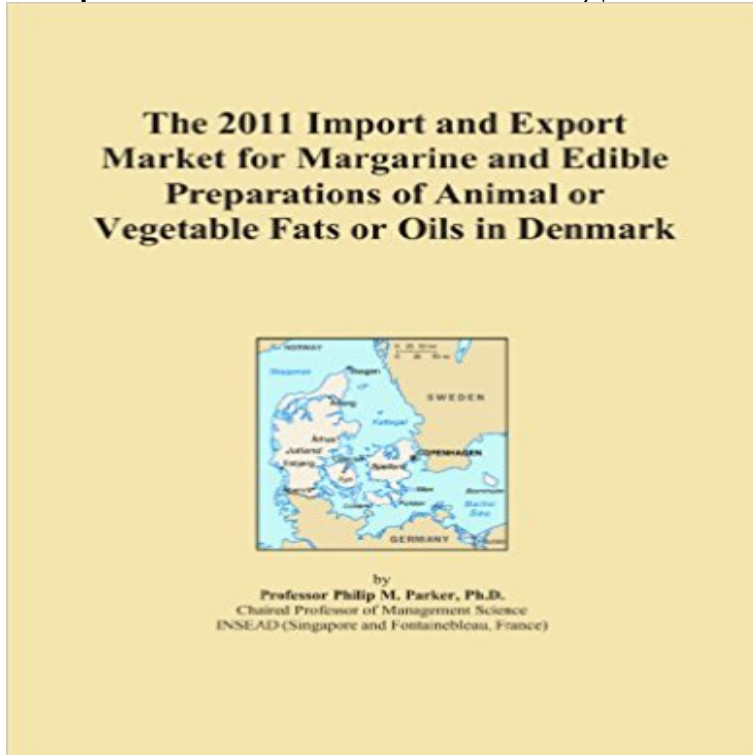


# The 2011 Import and Export Market for Margarine and Edible Preparations of Animal or Vegetable Fats or Oils in Denmark



On the demand side, exporters and strategic planners focusing on margarine and edible preparations of animal or vegetable fats or oils in Denmark face a number of questions. Which countries are supplying margarine and edible preparations of animal or vegetable fats or oils to Denmark? How important is Denmark compared to others in terms of the entire global and regional market? How much do the imports of margarine and edible preparations of animal or vegetable fats or oils vary from one country of origin to another in Denmark? On the supply side, Denmark also exports margarine and edible preparations of animal or vegetable fats or oils. Which countries receive the most exports from Denmark? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for margarine and edible preparations of animal or vegetable fats or oils in Denmark. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for margarine and edible preparations of animal or vegetable fats or oils for those countries serving Denmark via exports, or supplying from Denmark via imports. It does so for the current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2 begins by summarizing where Denmark fits into the world market for imported and exported margarine and edible preparations of animal or vegetable fats or oils. The total level of imports and exports on a worldwide basis, and those for Denmark in
