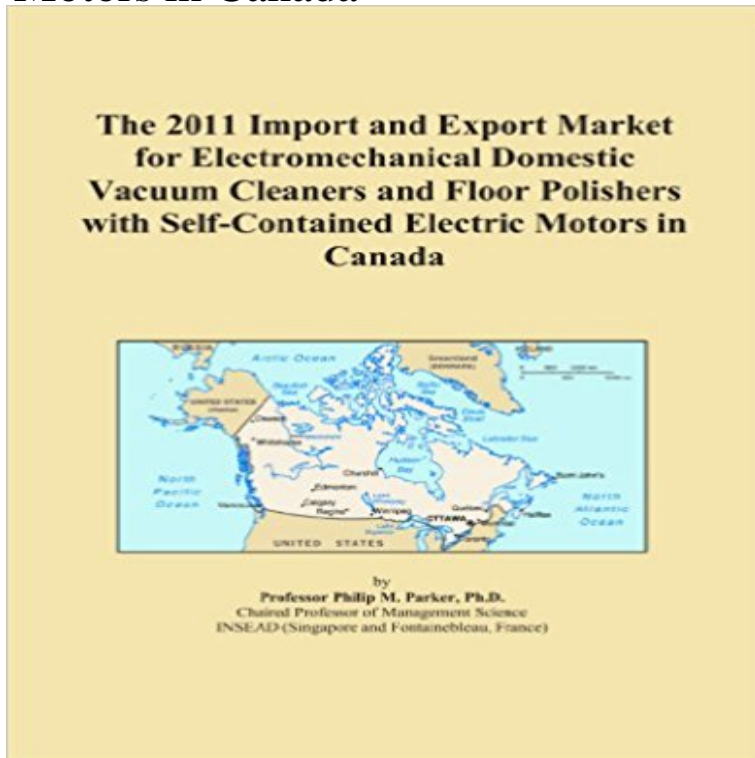


# The 2011 Import and Export Market for Electromechanical Domestic Vacuum Cleaners and Floor Polishers with Self-Contained Electric Motors in Canada



On the demand side, exporters and strategic planners focusing on electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors in Canada face a number of questions. Which countries are supplying electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors to Canada? How important is Canada compared to others in terms of the entire global and regional market? How much do the imports of electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors vary from one country of origin to another in Canada? On the supply side, Canada also exports electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors. Which countries receive the most exports from Canada? How are these exports concentrated across buyers? What is the value of these exports and which countries are the largest buyers? This report was created for strategic planners, international marketing executives and import/export managers who are concerned with the market for electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors in Canada. With the globalization of this market, managers can no longer be contented with a local view. Nor can managers be contented with out-of-date statistics which appear several years after the fact. I have developed a methodology, based on macroeconomic and trade models, to estimate the market for electromechanical domestic vacuum cleaners and floor polishers with self-contained electric motors for those countries serving Canada via exports, or supplying from Canada via imports. It does so for the current year based on a variety of key historical indicators and econometric models. In what follows, Chapter 2 begins

by summarizing where Canada fits into the world market for imported and exported electromechanical domestic vacuum cleaners and floor
