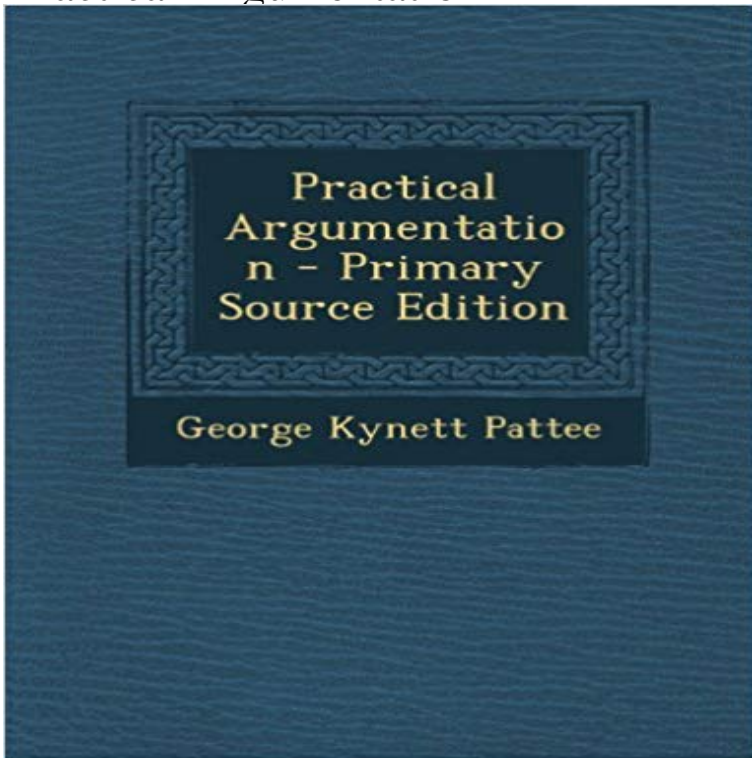


Practical Argumentation
