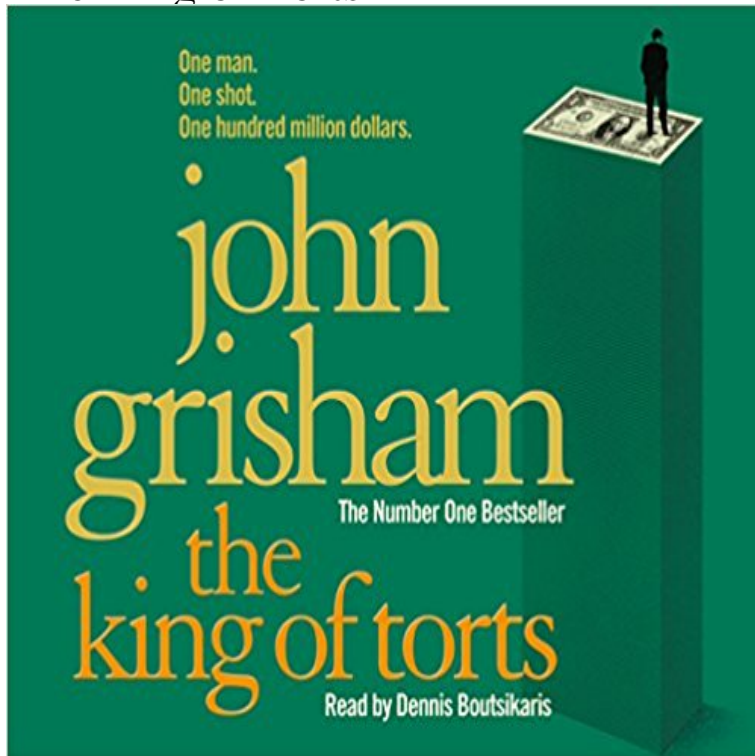


The King of Torts
